Code of Conduct 2017 - 2018

Solway Scallop and Static Gear Fishermen Luce Bay and Wigtown Bay areas, Solway Firth

1. Scallopers will give prior notice of intention to start working in the area to appropriate static gear contacts (below).
2. Scallopers will not start working a new area before 8am.
3. Static gear will be clearly marked with brightly coloured buoys or dhan flags.
4. Static gear ropes will be kept as short as possible.
5. Non-fishing static gear will not be stored on the seabed.

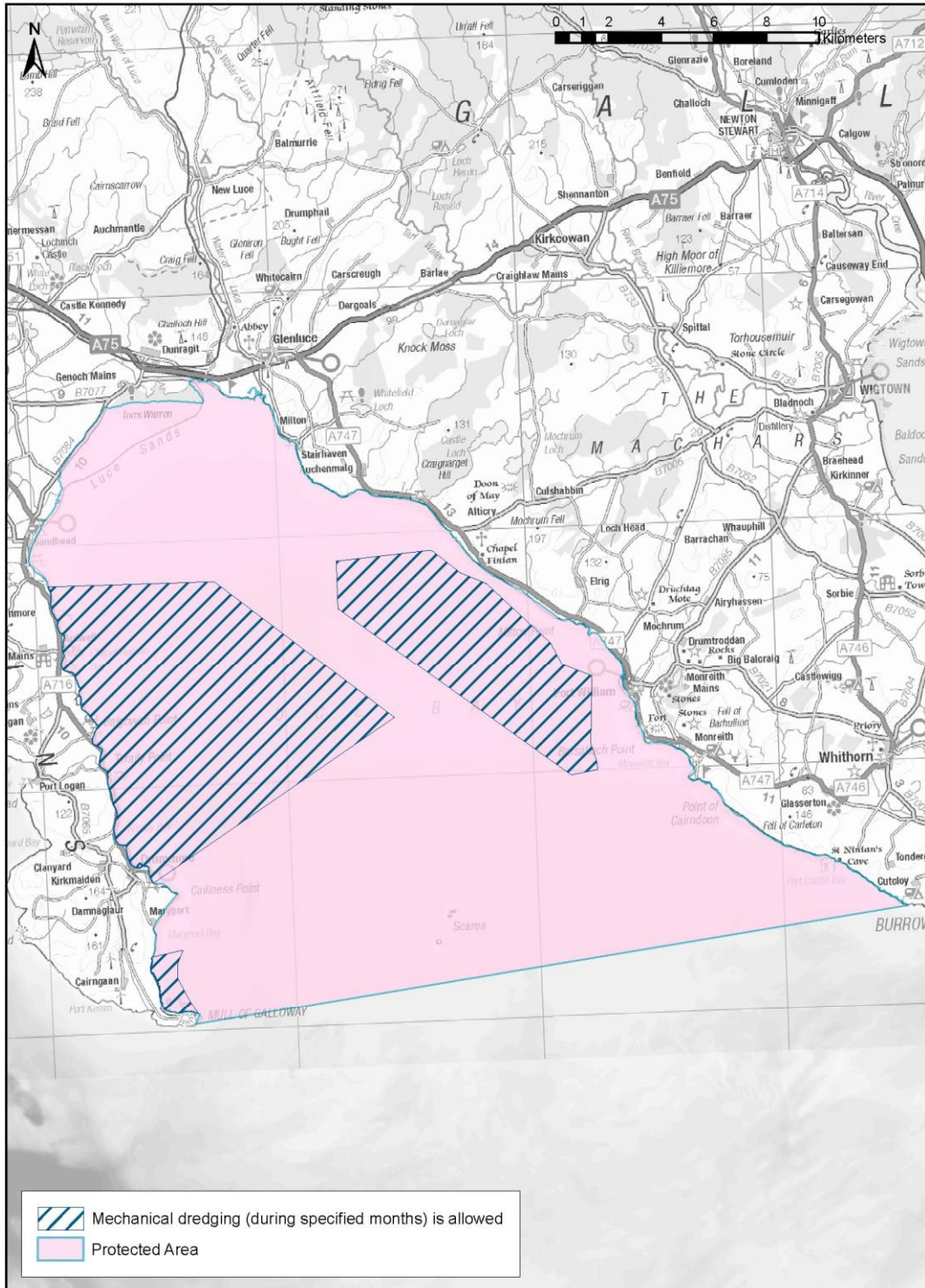

Luce Bay & Sands is a Special area of Conservation (SAC) and scalloping by trawlers is banned within the designated area shown in pink on the map below. Scallop dredging is permitted from the 1 November each year for four months in the three hatched areas shown on the map below.
